Charitable Donation By Gift

In the January issue of Hear & Now we began a series of articles designed to educate our members about the numerous ways in which people can support their favorite charities.

The January article was an overview of the various devices for charitable giving, including immediate gifts, wills, trusts, beneficiary designations in life insurance, IRAs, joint tenancy designations, and such sophisticated legal vehicles as charitable remainder trusts. Here we take up the subject of gifts, the most direct and immediate way of offering financial support.

A gift to a charitable organization is understood by all as a present delivery of value that can provide immediate help to an organization in serving its community. The donor receives not only the satisfaction of knowing that he or she has helped, but also a deduction from income tax for the value of the property in the year of the gift. The most obvious type of gift is, of course, cash.

Less known are a variety of other things that can be gifted to charity, and the special advantages of some of these gifts. For example, a donor can give personal property such as art, equipment, and office supplies that can be used by the charity, and take a tax deduction for the market value of the personal property. Another type of gift that is advantageous to all is stocks, bonds, and even real estate that has appreciated in value since acquired. When property that has increased in value is donated to a charity, the donor can take a tax deduction for the full, current market value of the property, and at the same time avoid capital gains taxes on the increase in value. Another good choice is an IRA, which allows the donor to take a deduction in the amount of the IRA's current full value while cancelling income taxes that would otherwise be due on IRA distributions.

Gifts can be made in the name of others whom a donor wishes to honor, such as family members and individuals whose contributions the donor wishes to recognize.

Let's Loop America!

In Southern Arizona it has been said that ALOHA is the go-to place to learn about inductive loop technology. Between the Tucson and Green Valley areas, over 70 facilities have loops installed, plus countless home installations. Across America, advocates, including audiologists, have started loop projects in their communities.

A Collaborative Effort! The Hearing Loss Association of America (**HLAA**), the American Academy of Audiology (**AAA**), and Hearing Charities of America (**Sertoma**) have announced an effort to collaborate on a national education campaign called ***“Get in the Hearing Loop”***

In her press release, Brenda Battat, executive director at HLAA states, “A new application of existing technology is gaining popularity in houses of worship, auditoriums, home TV rooms and retail stores, which is good news for the 36 million Americans who live with hearing loss.

“We believe that hearing loop technology when coupled with telecoils is a seamless, low-cost, unobtrusive, and effective way to improve the quality of life for people with hearing loss.”
